ORDER NO. 08-10-15-4

RESOLUTION AND ORDER REPEALING ORDER NO. 07-21-15-07.

WHEREAS, Texas Health & Safety Code § 775.0745, permits a district operating under Chapter 775, to order an election to increase the maximum tax rate of the District; and,

WHEREAS, the Board of Emergency Services Commissioners of Nueces County Emergency Services District No. 2 ("District") held a meeting called and conducted pursuant to all applicable law, including the Texas Open Meetings Act, on July 21, 2015 and passed Order No. 07-21-15-07; and,

WHEREAS, at its meeting held on July 21, 2015, the District ordered an election pursuant to Chapter 775, Health & Safety Code, and other applicable law, to be held on Nove 1ber 3, 2015 pending further discussion and action; and,

WHE EAS, issues related to the territorial boundaries of the District as well as other matte s made the election at this time unfeasible and moot as the Board of Emergency Services Commissioners hereby determines the action to be determined by the voters may not be taken, regardless of the outcome of the election; and,

WHEREAS, the time to order any election by the District is August 24, 2015 and such date has not passed at the time of this order; and,

WHEREAS, the District held a meeting called and conducted pursuant to all applicable law on July 10, 2015, and the District considered the issues related to Order No. 07-21-15-07, and whether to repeal said order;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF EMERGENCY SERVICES COMMISSIONERS OF NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 2 THAT:

- Section 1. That the statements contained in the preamble to this Resolution and Order are true and correct and are adopted as findings of fact and conclusions of law hereb.
- Section 2. Order No. 07-21-15-07 is hereby repealed, is null, void, and of no force or effect, and the Special Election called by the District to be held on November 3, 2015 is cancelled and shall not be held as previously ordered, as such order has been repea ed as moot.
- Section 3. The appropriate officers of the District are hereby authorized and directed to coordinate and oversee the implementation of this Order, and notify any other entities or individuals necessary to complete this Order of the District.
