Boat 95 no maintenances required this month

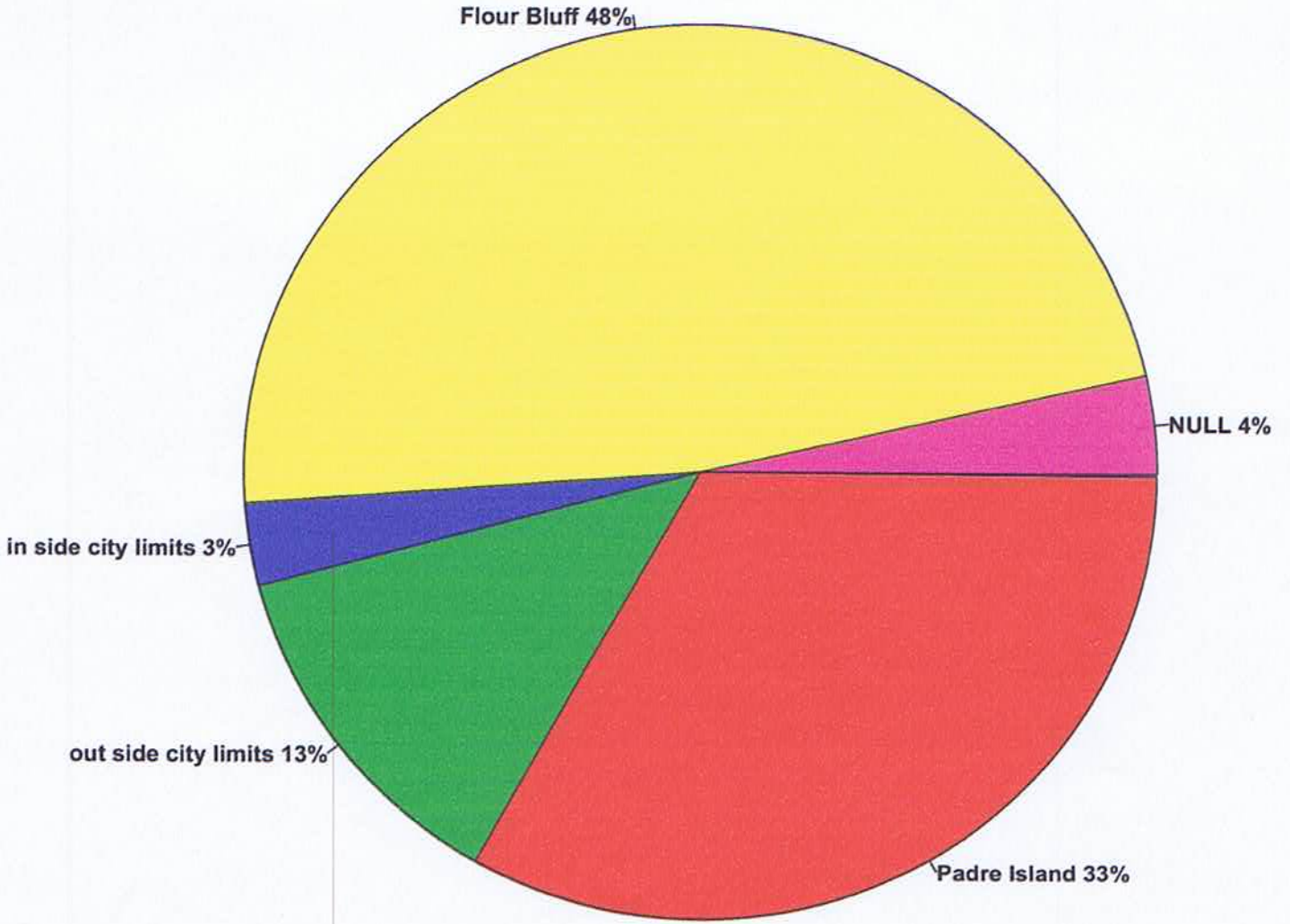
